

## 2020 PARENT/GUARDIAN PERMISSION FORM - WAYFINDERS

### Parent Consent Agreement for Camp, Events/Activities, and Transportation

If I am unable to provide transportation for my child, I give permission for him/her to receive transportation to and from the camp (Camp) my child will be attending as a Wayfinders participant, as well as to and from any Wayfinders sponsored events (Events). This transportation will be provided by a member of the Wayfinders Board, a Wayfinders volunteer, a professional driver, a Communities In Schools (CIS) employee or volunteer, or an employee or volunteer of the JCC of Charlotte (JCC). As a parent/guardian of the student named below, I hereby assume all risks and hazards incidental to experience of Camp, any Events, and transportation to and from same. I HEREBY RELEASE AND SHALL DEFEND, INDEMNIFY AND HOLD HARMLESS RELEASEES (as defined herein) FROM EVERY CLAIM AND ANY LIABILITY THAT I OR MY CHILD MAY ALLEGE AGAINST RELEASEES (including reasonable legal fees and costs) AS A DIRECT OR INDIRECT RESULT OF INJURY OR DEATH TO ME OR MY CHILD BECAUSE OF MY CHILD'S PARTICIPATION IN CAMP, ANY EVENT, OR TRANSPORTATION TO AND FROM SAME, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERS TO THE MAXIMUM EXTENT PERMITTED BY LAW. I PROMISE NOT TO SUE RELEASEES ON MY BEHALF OR ON BEHALF OF MY CHILD REGARDING ANY CLAIM ARISING FROM OR RELATED TO MY CHILD'S PARTICIPATION IN CAMP, ANY EVENT, OR TRANSPORTATION TO AND FROM SAME. I ACKNOWLEDGE THAT, BY SIGNING THIS DOCUMENT, I AM RELEASING AND HOLDING HARMLESS Wayfinders, CIS, JCC, AND EACH ORGANIZATION'S DIRECTORS, EMPLOYEES, VOLUNTEERS, AND AGENTS (COLLECTIVELY "RELEASEES") FROM LIABILITY, AND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS. THIS RELEASE FORM IS A CONTRACT WITH LEGAL AND BINDING CONSEQUENCES. I HAVE READ THIS RELEASE CAREFULLY BEFORE SIGNING. I UNDERSTAND WHAT THIS RELEASE MEANS AND WHAT I AM AGREEING TO BY SIGNING.

### Parent Consent Agreement for Photographs, Videos, and Interviews

I grant Wayfinders permission to use photographs and videos in which my child appears in its brochures, newsletters, DVDs, website, Facebook page, and any other publications or social media sites. This permission includes photographs and videos taken at Wayfinders events, taken by Wayfinders mentors and volunteers, and taken at camp. I also will allow Wayfinders to interview my child and me about the Wayfinders program and my child's camp experience. I understand that these interviews may be used by Wayfinders in its brochures, newsletters, DVDs, website content, Facebook page, and other publications and social media sites.

### Parent Consent Agreement for Access to Confidential CMS or Other School Records

I consent to Charlotte-Mecklenburg Schools (or any other school or school district where my child is enrolled) releasing the following data for my child to Wayfinders, my child's Wayfinders mentor(s), and Wayfinders' external evaluator for the purposes of 1) ensuring that my child meets the program's criteria and 2) measuring and evaluating the success and impact of the Wayfinders program: (a) Demographic data (that is, gender, race/ethnicity, grade level, school name); (b) Limited English Proficiency (LEP) Status; (c) Exceptional Children (EC) and/or Gifted (AIG) Status; (e) Course Grades; (f) Standardized Test scores, levels, proficiency (that is, beginning, middle and end of year district and state tests); (g) Attendance Data; (h) Behavior data (suspensions); (i) Promotion/Retention; (j) GPA (High School Students Only); (k) Graduation Status (High School Students Only); (l) Credits Earned and Credits Attempted (High School Students Only); (m) Address/Telephone Numbers for Parents, Guardians, and Emergency Contacts; and (n) Immunization records. This permission covers the year prior to my child joining the Wayfinders program and remains in effect for five years after my child graduates from or otherwise leaves the Wayfinders program.
